Dear Sir,

I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that **Islam Sekh** was enjoying Electricity un-authorizedly by reconnecting energy meter vide Meter No: **B3783698** Consumer Id: **201821118** of W.B.S.E.D.C.L.

On dated **26.09.2023** the meter was disconnected due to non-payment of Electricity Energy bill. And by reconnecting on his own **Islam Sekh** has committed theft of electricity u/s 138 (1) (a) & 138 (1) (b) of the Electricity (Amendment) Act-2007.

On dated **14.08.2024** at around **11:00 AM** myself **Shri Biswajit Pal, J.E. (I) Gr-II & Station Manager** along with **Shri. Jayanta Banerjee, Sr. OE** and **Shri. Dharapani Mahato, Sr. TSH** both posted at Hura CCC, WBSEDCL, has entered the premises of **Islam Sekh, S/o: Kalu Sekh** and inspected his premises. During inspection theft of electricity was detected u/s 138 (1) (a) & 138 (1) (b) i.e., he was using electricity by un-authorizedly reconnecting the energy meter which was disconnected by the office for non-payment of Electricity Energy Bill.

From the above arrangement, he was using the following electrical equipments:

1. Electric Fan= 03 No's.
2. Electric Light Bulb= 08 No's.

After that the inspection team left the premises at around **11:10 AM** on **14.08.2024**.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
