I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that Sri. Niranjana Dutta was enjoying Electricity un-authorizedly by bypassing energy meter vide Meter No: 1.1354965 Consumer Id: 242012209 of W.B.S.E.D.C.L.

On dated 14.08.2024 at around 12:55 PM myself Sri. Biswaji Pal, J.E. (E) Gr.II & Station Manager along with Sri. Jayanta Boskey, Sr. OE & Sri. Dharapati Mahato, Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of Sri. Niranjana Dutta, S/o: Lt Dwijapada Dutta and inspected his premises. During inspection theft of electricity was detected u/s 135 (1) (b) & 135 (1) (c) i.e., he has tampered the energy meter vide meter no: 1.1354965 and was using electricity through a tampered energy meter.

From the above arrangement, he was using the following electrical equipments:

1. Electric Light Bulbs - 5 Nos
2. Electric Water Motor - 1 Nos
3. Electric Fan - 2 Nos

Out of which I seized the following electrical items:

1. Flexible Wire approx 20 Feet long.

Seizure list was prepared at the site, the accused person refused to sign. After that the inspection team left the premises at around 1:05 PM on 14.08.2024.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
