Sir,

I, ASI Prakas Senapati along with force returned to PS with 01 (one) arrested accd. person namely Sk Abrar (24 Yrs) S/O Sk Ohab of Bagandih, Jhalda Municipality Ward No-07, PS- Jhalda, Dist-Purulia driver of Mahindra Maxx Pik Up having Registration No- WB556645 along with seized article i.e. one Mahindra Maxx Pik Up having Registration No- WB556645 loaded with approx 1.5 Ton of steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (26/08/2024) myself along with force namely C/864 Mahabir Mahato, C/2111 Mohitosh Mahato & NVF/933 Abani Kumar were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 1228/24 Dated- 26/08/2024 in consonance with Jhalda PS CC No- 2583/24 Dated- 26/08/2024. During my evening mobile duty, at about 17:45 hrs, received a tip off that 01 (one) Mahindra Maxx Pik Up loaded with stolen steam coal was coming from Jharkhand side along Gola Road towards Jhalda. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No 1234/24 dated 26/06/2024. Consequently, as per your kind order I started Naka at near Kansra no entry point by placing the guardrail on the Gola Road. Thereafter I saw the 01 (one) Mahindra Maxx Pik Up was proceeding towards Mosina more. Consequently, we intercepted the said Mahindra Maxx Pik Up at Naka checking point at about 19:45 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that pik up tried to flee away. After hot chase we managed to apprehend him and the Mahindra Maxx Pik Up having Registration No- WB556645 loaded with approx 1.5 Ton of steam coal. On being asked, the driver of the pik up disclosed his identity as noted in the supra. I asked the driver of the pik up to produce the valid documents in respect of the Mahindra Maxx Pik Up as well as the loaded steam Coal. But he could not able to produce any kind of documents in respect of the said pik up and the loaded steam Coal. We waited for reasonable time but none came to spot to produce any documents in respect of the said pik up loaded with steam Coal. So it is reasoned to belief that the driver & Owner of the said pik up in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, So I seized the Mahindra Maxx Pik Up having Registration No- WB556645 loaded with approx 1.5 Ton of steam coal after preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Sk Abrar (24 Yrs) S/O Sk Ohab of Bagandih, Jhalda Municipality Ward No-07, PS- Jhalda, Dist-Purulia after informing him the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said seized articles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accused person namely Sk Abrar (24 Yrs) S/O Sk Ohab of Bagandih, Jhalda Municipality Ward No-07, PS- Jhalda, Dist-Purulia, (ii) The owner of the said Mahindra Maxx Pik Up having Registration No- WB556645 as they committed offence U/S- 303(2)/317(2)/317(4)/317(5) BNS.
