Sir,

In producing here with 01 (one) accused person namely Joydeb Mahato (28 years) S/O Subhas Mahato of Vill-Ankura, PS-Jhalda, Dist-Purulia (Driver of Bolero pick up having Reg. No. WB55A8395) along with seized articles i.e. 01 (one) Bolero Pick up having Reg. No- WB55A8395 loaded with (i) 60 bags potato weight approx. 48 Kg of each and total weight approx. 28.08 Quintal. To the effect that I, ASI Swapan Kr. Barik along with C/814 Sushabhan Goswami, NVF/933 Abani Kumar all of Jhalda PS Dist-Purulia vide CC No-2359/24 Dated-08.08.2024 were engaged in Naka checking duty at New PS Bortol NAKA point on Purulia-Ranchi Pitch Road under Jhalda, PS Dist-Purulia and found the above noted Bolero Pick up was coming from Kotshila side towards Jhalda via Purulia Ranchi road. Then, we stopped the said Pick up loaded with some goods which were covered by plastic Tarpaulin. On searching it is learnt that approx. 60 bags loaded with potato weight approx. 48 kgs in each bags. Total weight approx. 28.08 Quintal. On being asked the driver of the said vehicle failed to produce any valid challan/ documents in respect of above noted potatoes as well as any papers in respect of above noted vehicle, and he made incoherent statements. On interrogation, he disclosed his name and address as noted above. He also disclosed that one Santosh Saw S/O Lt. Gaur Chandra Saw of Bandhaghat, Ward No- 07 of Jhalda Municipality, PS- Jhalda, Dist- Purulia is the register owner of above noted vehicle and as per direction of the owner of the said vehicle he transporting the Potatoes to Jharkhand state. So, it is reasonable to believe that the driver & owner of the above noted vehicle collected the said potato either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted vehicle transporting sand illegally. So, I seized the same under proper seizure list in between 19:05 hrs to 19:40 hrs. During further interrogation he confessed his guilt as such I arrested him on today (08/08/24) at 19:45 hrs after observing all the formalities as the accused persons & the owner of the vehicles is liable for prosecution U/S-303(2)/317(2) BNS. But owner of the said vehicle is not present in this vehicle, So I unable to arrested him

I therefore pray before you, kindly lodge an FIR against the owner of the Bolero Pick having Reg. No- WB55A8395 loaded with 60 bags Potato namely Santosh Saw S/O Lt. Gaur Chandra Saw of Bandhaghat, Ward No- 07 of Jhalda Municipality, PS- Jhalda, Dist- Purulia and arrested accused driver of the said vehicle namely Joydeb Mahato (28 years) S/O Subhas Mahato of Vill-Ankura, PS- Jhalda, Dist-Purulia as per law and arrange for its investigation.
