Sir,

In producing here with one arrested accused person namely Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar near Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 25 (Twenty five) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup styled as ONEREEX Cough Syrup @ 165.50/- per bottle, having 100 ml in each bottle in a bag from the dwelling house of the accused person as mentioned above. I SI Sanjib Kr. Chatterjee of Jhalda PS do here by lodged a written complaint against Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar near Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia to the effect that today (13/08/2024) while performing Spl. raid duty (This refers to Jhalda P.S. GDE No- 605 Dt- 13/08/2024, vide C.C. No- 2421 Dt- 13/08/2024) near at Birsamore, I received an information from my source at about 21:15 hrs that one person namely Manish Swarnakar has stored huge quantity of Cough Syrup for selling clandestinely from his dwelling house near Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia to the youth customers of Jhalda town area. After having received this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I SI Sanjib Kr. Chatterjee along with (i) C/331 Mansaram Kumar, (ii) C/1394 Gurudas Bauri both of Jhalda PS left Birsamore immediately to work out the information. We, all reached with Govt. Vehicle near Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia at 21:25 Hrs. and held raid in the house of Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar near Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia and found (i) 25 (Twenty five) Pcs sealed bottles of Triprolidine Hydrochloride & Codeine Phosphate Syrup styled as ONEREEX Cough Syrup @ 165.50/- per bottle, having 100 ml in each bottle in a bag. On interrogation he disclosed his identity as mentioned above. On demand he failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as on request no one of his family members come forward to be the witness in this case and as well as signed by the apprehended person and also prepared label with seal and from which 01 (one) bottle of cough syrup was kept as sample. He also disclosed that he was running Cough Syrup (illegal drugs) business since long from his dwelling house illegally and today he was with huge quantity of Cough syrup in his house and keep there for the purpose of selling illegal drugs to the local youth customers. Subsequently, I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused person namely Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar near Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
