- 1... That your complainant is the legally married wife of the accused No.1 Samanta and marital tie between them is still subsists.
- 2...That marriage between the Complainant and Opposite Party No.1 was solemnized on 02/05/2022 corresponding to the 18th day of Baisakh 1429 as per Bengal Calendar, according to Hindu ritual and customs prevails in their society at Village & P.O. Shrirampur, P.S. Joypur, District- Purulia, in presence of both the family members and near relatives of the parties and within the jurisdiction of this Ld. Court.
- 3...That at the time of marriage the father of the complainant gave Cash amounting Rs. 1,50,000/- (Rupees one lack and fifty thousand only), Golden Ornaments weighing 80



grams, silver Ornaments weighing 50 grams, Steel Almirah, Divan, Dressing Table, Refrigerator etc. and all household utensils including Dinner Sets made of steel and kasha, as per demand of the Opp.Party and his family members. Moreover the father of the complainant expended around Rs.8, 00,000/- with a hope that her daughter would start happy conjugal journey in her matrimonial house.

- 4...That after marriage the complainant went to her matrimonial house with the Opposite Party No.1 at Village & P.O. Garhjoypur, P.S. Joupur, District- Purulia with a dream to start a happy conjugal life.
- 5...That soon after performing "Astamangala Ritual" the complainant fall victim of immense physical and mental torture in the hands of the Opposite Party No1 to 5 for bringing in adequate dowry and also teasing her by saying that the Ornaments, furniture's given by the father of the complainant are of very inferior of quality.
- 6...That from the outset of her marital life your complainant fall victim of teasing by the Opposite Party/ Respondent and his family members. The Opposite Party and his family members started to putting pressure upon the complainant to bring Rs.1, 00,000/- from her father as extra amount of dowry and when the complainant expresses her father's inability to pay such huge amount of additional dowry the complainant was subjected to mental and physical torture in the hands of the opposite party No.1 to 5.
- 7...That the caustic comments and the torture in way of both that is physical and mental by the opposite party No.1 to 5 causes immense mental and physical pain, but the complainant had to tolerate all such indignity and cruelty silently in lieu of extra demand of dowry money of Rs. 1, 00,000/- from her father .
- 8...That the complainant was never provided with proper food and clothing by the opposite party No.1 and the opposite party adopted a habit to beat the petitioner off and on by raising petty household issues.
- 9...That the brother in laws of the petitioner i.e. Opposite Party No. 3. Sandip Bauri, Opposite Party No.4. Sonu Bauri and opposite party No.5 even used to molest the complainant whenever they found her alone in her matrimonial house and when the petitioner inform the matter to the opposite party No.1 she was brutally physically assaulted by the opposite party No.1, and finally all the opposite party (OP No.1 to 5) driven the complainant out from her matrimonial house on 5/02/2024 after beating her mercilessly. Since then your complainant is residing in her matrimonial house.
- 10...That on 10/05/2024 your complainant went her matrimonial house with her parents but she became surprise when the opposite party No.1 to 5 did not allowed the complainant to enter in to her matrimonial house rather the father in law of the complainant (OP No.2) desperately told her that they have solemnized second marriage of the Opposite Party No.1 by pointing towards a newly wedded women in the house of the opposite parties.
- 11.. That the Complainant repeatedly visited Joypur P.S to lodge complain at against

the accused persons but reason best known to the Police Officer of Joypur P.S to not lodge complaint against the accused persons finally the Complainant on 25/06/2024 send her typed complained to the I.C. Joypur P.S. through registered post but no action taken against the accused persons by the police of Joypur P.S.

6...That 29.06.2024 the Complaint inform the matter to the S.P. Purulia but till date no action has been taken against the accused persons as such having no other alternatives your Complainant filing this Misc. Petition u/s 175(3) of B.N.S.S. before this Ld. Court.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition filed u/s 175(3) of B.N.S.S. and treating the same as a F.I.R. be pleased to send it to I.C.
