On 08.08.2024 at about 01.05 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, Age- 46 Yrs, AE & Station Manager, Joypur CCC along with Raushan Kumar,JE(E) Gr-II, Joypur CCC, Ganesh Mahato, Gr-1 TSH, Joypur CCC and Shibaram Mahato, Gr-I TSH, Joypur CCC entered the premises of , Ananda Marga Jagriti & School C/O- Pragyadishananda Abadhut, Working Teacher Bahadur Mahato S/O- Late Lakhiram Mahato of Vill- Dimdiha, PO- Ghagra, P.S- Joypur , Dist- Purulia and found that the School authority supplied electricity unauthorizedly from their existing defective meter (No. L4232465, Con ID: 201748257) to another premises of deemed disconnected connections of having Consumer ID: 202354292 of Purnima Mahato W/O- Bahadur Mahato with outstanding dues and total connected load found 2.52 kVA. The connection is disconnected on date. As Ananda Marga Jagriti & School C/O- Pragyadishananda Abadhut, Working Teacher Bahadur Mahato S/O- Late Lakhiram Mahato committed an offence U/S 135 1(e) Electricity Act, 2003(Amendment Act, 2007), I seized the following articles after preparing the seizure list in presence of Raushan Kumar,JE(E) Gr-II, Joypur CCC, Ganesh Mahato, Gr-1 TSH, Joypur CCC and Shibaram Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 01.40 P.M.
