Sir,

In producing here with 01 (one) accused person namely Parkeet @ Parikshit Mahto S/o Late Bhupnath Mahta of vill Shilphore, PS Pindrajora, Dist Bokaro, State- Jharkhand (Driver of Bolero Pick up having Reg. No-JH09BA/8313) along with seized articles i.e. 01 (one) Bolero Pick up having Reg. No-JH09BA/8313 loaded with (i) 88 bags pointed gourd, weight approx. 20 Kg of each and total approx. 1.76 Quantal, (ii) 10 bags Bottle Gourd, weight approx. 20 Kg of each and total approx 2 Quantal (iii) 08 bags Ivy Gourd weight approx. 25 Kg of each and total approx. 02 Quantal and 20 bags Potato weight approx. 50 Kg of each and total approx. 10 Quantal, to the effect that I, ASI Shibaram Bauri along with C/1322 Dilip Kr. Baskey, C/ 1358 Sanjib Kr. Patra, and C/157 Dipak Bauri all of Jyopur PS Dist-Purulia vide CC No-2265/24 Dated-07.08.2024 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Jyopur PS Dist-Purulia and found the above noted Bolero Pick up was coming from Chas more side via NH-32 towards Kathaltard. Then, we stopped the said Pick up loaded with vegetables and asked the driver regarding valid challan of vegetables, then he made incoherent statements. Hence, we searched the vehicle thoroughly and found (i) 88 bags pointed gourd, weight approx. 20 Kg of each and total approx. 1.76 Quantal, (ii) 10 bags Bottle Gourd, weight approx. 20 Kg of each and total approx 2 Quantal (iii) 08 bags Ivy Gourd weight approx. 25 Kg of each and total approx. 02 Quantal and 20 bags Potato weight approx. 50 Kg of each and total approx. 10 Quantal which were covered by plastic Tarpaulin under those vegetables. On being asked, the said driver only produce valid papers of those vegetables but he could not produce any valid papers in respect of carrying those 20 bags Potato. On interrogation, he disclosed his name and address as noted above. So, it is reasonable to believe that the driver & owner of the above noted vehicle collected the said potato either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted vehicle transporting sand illegally. So, I seized the same under proper seizure list in between 15:55 hrs to 16:15 hrs. During further interrogation he confessed his guilt as such I arrested him today at 16:25 hrs as the accused persons is liable for prosecution U/S-303(2)/317(2) BNS.

I therefore pray before you, kindly lodge an FIR against the owner of the Bolero Pick having Reg. No-JH09BA/8313 loaded with 20 bags Potato and arrested accused driver Parkeet @ Parikshit Mahto S/o Late Bhupnath Mahta of vill Shilphore, PS Pindrajora, Dist Bokaro, State- Jharkhand as per law and arrange for its investigation.

In forwarding herewith one arrested FIR named accused person namely Parkeet @ Parikshit Mahto S/o-Late Bhupnath Mahta of vill Shilphore, PS-Pindrajora, Dist Bokaro, State- Jharkhand (Driver of Bolero Pick up having Reg. No-JH09BA/8313) before your Honour Court in c/w the above referred case under proper police escort with all connecting papers. I beg to state that 07/08/2024 in between 15:55 hrs to 16:25 hrs Naka checking was going on at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS by ASI Shibaram Bauri and his team, he also seized 01 (one) Bolero Pick up having Reg. No-JH09BA/8313 loaded with (i) 88 bags pointed gourd, weight approx. 20 Kg of each bag and total approx. 1.76 Quantal, (ii) 10 bags Bottle Gourd, weight approx. 20 Kg of each and total approx 2 Quantal (iii) 08 bags Ivy Gourd weight approx. 25 Kg of each and total approx. 02 Quantal and 20 bags Potato weight approx. 50 Kg of each and total approx. 10 Quantal & arrested one accused person namely Parkeet @ Parikshit Mahto S/o-Late Bhupnath Mahta of vill Shilphore, PS-Pindrajora, Dist Bokaro, State- Jharkhand (Driver of Bolero Pick up having Reg. No-JH09BA/8313). On demand he failed to produce any valid papers in respect of carrying of Potato. So, it is reasonable to believe that the driver & owner of the above noted vehicle collected the said Potato either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted vehicle transporting Potato illegally. Over which above noted case has been started. I, SI Gautam Kr. Mandal Joypur PS took up its investigation as per endorsement of IC Joypur PS.

During investigation of this case, I examined the complainant and other witnesses and recorded their statements U/S-180 (1) BNSS, visited the P.O, prepared rough sketch map of the P.O, verified seizure list and the accused person namely Parkeet @ Parikshit Mahto S/o-Late Bhupnath Mahta of vill Shilphore, PS-Pindrajora, Dist Bokaro, State- Jharkhand (Driver of Bolero Pick up having Reg. No-JH09BA/8313) has already been arrested by the complainant ASI Shibaram Bauri after maintaining all the formalities regarding arrest and all the guideline of Honorable Supreme Court and NHRC regarding arrest. I interrogate the said accused person thoroughly. On interrogation, he confessed his guilt and admitted that he has committed the offence.

I, therefore, pray before your Honours Court that the above noted arrested accused person may kindly be taken into your taken honour custody and detained in JC till the investigation is completed.

I strongly opposed his bail move in the initial stage of investigation.
