Sub - Prayer for lodging FIR

Respected Sir,

In producing herewith arrested accused person Anil Tudu (25 Years), S/O -Lt Samu Tudu C/O Fuchu Tudu of village - Dhapahari, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 03.08.2024 at 17.55 hrs during my special mobile duty I found some persons were assembled near Talajuri More in a road side open land besides Kashipur - Chhatna main road and taking liquor. Accordingly I stopped the vehicle and myself along with force (1) C/850 Taraknath Mondal (2) C/2280 Akinchan Mondal both of Kashipur PS, Dist - Purulia rushed towards the spot and found that one person was selling ID liquor. After seeing us some people fled away from there and we managed to apprehend the seller. On interrogation he disclosed his name and address i.e. Anil Tudu (25 Years), S/O - Lt Samu Tudu of village - Dhapahari, PS -Kashipur, Dist - Purulia. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found one white colour plastic jarikin loaded with approx 09 (Nine) liters ID liquor (Chullu) out of seized ID liquor 500 ml taken out in a bottle as sample with sealed and labeled. I also seized and labeled all the seized articles at the spot in presence of accused person and witnesses in between 18.05 hrs and 18.55 hrs. Accordingly I arrested the above noted accused person at 19.05 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46A(c) B.E. Act 1909 against arrested accused person Anil Tudu (25 Years), S/O – Lt Samu Tudu C/O Fuchu Tudu of village – Dhapahari, PS - Kashipur, Dist - Purulia and arrange for its investigation.
