Sub - Prayer for lodging FIR

Respected Sir,

In producing herewith arrested accused person Ram Ranjan Kansari (65 Years), S/O - Lt Sabar Kansari of village - Kashipur, Kansari Para, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 22.08.2024 at 19.05 hrs during my evening mobile duty I found some persons were assembled at Kashipur Kansari Para More under PS - Kashipur Dist - Purulia near the house of above noted accused and taking liquor. Accordingly I stopped the vehicle and myself along with force (1) C/850 Taraknath Mandal (2) C/1415 Swapan Kr Mandal both of Kashipur PS, Dist - Purulia rushed towards the spot and found that one person was selling CS liquor. After seeing us some people fled away from there and we managed to apprehend the seller. On interrogation he disclosed his name and address i.e. Ram Ranjan Kansari (75 Years), S/O - Lt Sabar Kansari of village - Kashipur, Kansari Para, PS - Kashipur, Dist - Purulia. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found the following articles i.e. (1) One Yellow colour plastic bag containing (a) "Dil Khush" 600 ML x 4 Bottles = 2400 ML Total Rs 220/- (b) "Dil Khush" 300 ML x 6 Bottles = 1800 ML Total Rs 180/- (c) "Imperial Blue" 375 ML x 2 Bottles = 750 ML Total Rs 660/- (d) "Imperial Blue" 180 ML x 3 Bottles = 540 ML Total Rs 540/- (e) "Mc Dowells Luxury" 375 ML x 2 Bottles = 750 ML Total Rs 680/- (f) "Plane Mc Dowells" 375 ML x 2 Bottles = 750 ML Total Rs 660/- (g) "Mc Dowells Luxury" 180 ML x 4 Bottles = 720 ML Total Rs 720/- (2) One Green & White Colour Plastic Bag containing (a) "Royal Stag" 375 ML x 1 Bottle = 375 ML Total Rs 390/- (b) "Royal Stag" 180 ML x 2 Bottle = 360 ML Total Rs 420/- (3) One white colour Plastic Jarikin containing approx 5 liter ID liquor (Chullu) out of those seized liquor sample have been taken out from each category of Brand with sealed and labeled (Total seized articles (i) Dil Khush 4200 ML (ii) Total Foreign Liquor 4245 Liter and (iii) ID liquor approx 05 Liter, Total amount of seized liquor approx 4470/- (4) 10 used Plastic Glass (5) 02 empty Bottel of Dil Khush. I also seized and labeled all the seized articles at the spot in presence of accused person and witnesses in between 19.15 hrs and 19.55 hrs. Accordingly I arrested the above noted accused person at 20.05 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46A(c) B.E. Act 1909 against arrested accused person Ram Ranjan Kansari (75 Years), S/O - Lt Sabar Kansari of village - Kashipur, Kansari Para, PS - Kashipur, Dist - Purulia and arrange for its investigation.
