 I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity U/S-135(1)(a) Electricity amendment Act-2007 to the effect that Sri Uttam Kumar Modak, S/O- Guhram Modak, Village - kashipur, adra kashipur road, PS-kashipur, Dist. - Purulia was enjoying electricity by means of unauthorized extention of load from other meter with same premises and suppressing of the fact of the deemed meter OSD amount.

Entered the premises of Sri Uttam Kumar Modak, S/O- Guhram Modak, Village - kashipur, adra kashipur road, PS-kashipur, Dist. - Purulia During the inspection it was found that the consumer (actual user) was consuming electricity through meter no. L4622562 dishonestly without clearing of the OSD amount of previous meter at his premises L4374460 in the name of his wife Mita Modak and L4622562 in his name.

From the above inspection it was found that he was using using electrical equipment of total load of 0.200 KW  
 Out of which the following item has been seized:

- 1) 1- core single wire Copper PVC Cable of 30 ft approx with hooking device.

Seizer list is prepared at the site and accused person refuse to sign the list.

The inspection team left the premises at 3:35 P.m on dated 30.08.2024, the accused person has committed an offence U/S- 135(1)(E) of the electricity amendment Act - 2007

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be as per rule.
