

- 2. That the accused person is the owner of the land mentioned here under in the schedule.

That it is to be further submitted that the accused person persistently asked the complainant to surrender his BARGA POSSESSION of the land mentioned below in favour of the accused person by taking some money and being refused one day on the date of occurrence on 5/11/2023 at about 11 Am came to the house of the complainant and abused the complainant and inmates in fiithy language and used filthy language calling the caste BAURI of

Thus the accused person has committed offence u/s 3(L) (s) of the provisions of SC/ST atrocity Act.

- That with the intervention of the witnesses, the accused person left the PO.
- That the accused person lodged complaint before Kashipur Ps. & thereafter lodged complaint before S.P Purulia on 22/11/202ま in spite of that till this day no action taken ,hence the complainant has been compelled to come before your Honour for redressal.
