I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity amendment Act-2007 to the effect that Sri Ashok kumar Dey S/O- Kartik Dey Village -Sonathali (Ashram), Post- Sonathali, PS-kashipur, Pin-723132, Purulia was enjoying electricity unauthorizely reconnecting of his energy meter with electric line which was disconnected long ago due to non payment of electric energy bill ,he has committed theft U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007 on 16.08.2024 at 3.55 PM I Sri Somnath Burman AE(E) & Station Manager of Kashipur CCC, WBSEDCL along with.

1. Sri Suprakash Layek, JE(E), Kashipur CCC, WBSEDCL
2. Sri Uttam kumar Mahatha, Sr TSH, Kashipur CCC, WBSEDCL

Entered the premises of Sri Ashok kumar Dey S/O- Kartik Dey Village -Sonathali (Ashram), Post- Sonathali, PS-kashipur, Pin-723132, Purulia and inspected his premeses. During the inspection theft of electricity was detected U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007 i.e. he was consuming electricity unauthorisedly by reconnecting of his energy ,having meter no B3316022 and Consumer ID 201578268 of WBSEDCL with electric line being the property of a licensee when the said electric line has been disconnected.

From the above inspection it was found that he was using total load of electrical equipment **Total 200 watt**
Out of which I seized the following electric items

- 1) meter no B3316022 of make Bentec of manufacturing year 01/2015.

Siezure list is prepared at the site and accused person denied to sign. The inspection team left the premises at 04.05 P.M on dated 16.08.2024. The accused person has committed an offence U/S-138(1)(a) & 138 (1) (b) of the Electricity amendment Act-2007
