Sir.

In producing here with accessed accused persons namely (1) Usman Shah (34 yrs) S/O-Lt Gularo Shah of Vill Hudagara, PS-Arsha, Dist.- Purulia and (2) Trilochan Kumar (23 yrs) S/O-Lt Mahabir Kumar of Vill-Barobendya, PS-Joypur, Dist. - Purulis and seized articles (1) One country made pipe gan (iron made) length (0 % inches having iron butt, body, burrel, trigger, firing pin etc and (2) One live ammunition marked as "OK 72" (3) one iron rod approx length 3 feet lodged complaint against them and their other associates to the effect that on 05.08.24 at about 00.25 hrs received a credible tip that a gang of dacoits being armed with deadly weapons like firearms assembled beside Purulia-Rauchi road near Kotshiia Railway Station under Jiudaru Mouza and they were preparing themselves for committing decoity near Kotshila bazar area. This matter was informed to O/C Kotshila PS and Duty Officer ASI Prasanta Kr Pan to note down the information down to the GDE Vide Kotshila PS GDE No 191 Dated 05.08.24. On getting the tip off as per kind order of O/C Kotshila PS, myself along with force namely C/692 Ukil Ch Mahato and C/293 Subhasish Chakraborty all of Kotshila PS vide CC No. 3367/24 dated 05.08.24 & ODE No. 192 Date, 05.08.24 and night mobile officer ASI Rajkumar Goswami, C/1362 Achinta Majee, C/1362 Patilt Ch Roy and C/3334 Muktar Ansari vide Kotshila PS CC No. 3365/24 Date. 04,08.24 immediately proceeded to the anticipated place of assembly to work out the information and reached near Kotshila bazar at 00.55 hra from the Police vehicle No. WB 26 C-7292 and started to proceed for the anticipated place on foot. At 01:05 hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that a gang of 08/10 persons assembled in the beginning of the beside Purulia-Ranchi road near Kotshila Railway Station under Jiudaru Mouza and those persons were whispering from which it was clear that they were preparing themselves to commit decoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed to our words and tried to fice away. We succeeded in rounding up only [2] Two of them at 01:20 hrs while the rest managed to escape despite a hot chase after them. They disclosed their identity as mentioned above. We told them that we want to search them and if necessary they can search us, but they informed us that they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered [1] One country made pipe gun (iron made) length 10 % inches having iron butt, body, barrel, trigger, firing pin etc and (2) One live ammunition marked as "OK 72" from the exclusive possession of Usman Shah and (3) one iron rod approx length 3 feet of Trilochan Kumar. Then in between 01:25 hrs to 01:40 hrs on 05:08.24 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (I) One country usade pipe gun (iron made) length10 1/2 inches having iron butt, body, barrel, trigger, firing pin etc and (2) One live ammunition marked as "OK 72" (3) one iron rod approx length 3 feet under proper seizure list as well as labeled duly signed by the apprehended persons and witnesses as Alamat property in c/w above case. Then from

01:50 hrs to 01:55 hrs I arrested 02 (two) persons namely (1) Usman Shah (34 yrs) S/O-Lt Gulam Shah of Vill-Hudagara, PS-Arsha, Dist.- Purulia and (2) Trilochan Kumar (23 yrs) S/O-Lt Mahabir Kumar of Vill-Barobendya, PS-Joypur, Dist.- Purulia. Issued Memo of arrest and observed all legal formalities informing them regarding ground of arrest and informed their family members. On interrogation they confessed the guilt and they stated that they had assembled there with 08/10 others for committing house dacoity at Kotshila bazar area.

I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity armed with deadly firearms and weapons which might be dangerous for life of public witnesses, so I restrained collecting weapons which might be dangerous for life of public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I persons were assembled there for committing house dacoity. So, after observing all formalities I arrested them preparing an arrest memo and the ground of arrest was duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Usman Shah (34 yrs) S/O-Lt Gulam Shah of Vill-Hudagara, PS-Arsha, Dist-Purulia and (2) Trilochan Kumar (23 yrs) S/O-Lt Mahabir Kumar of Vill-Barobendya, PS-Joypur, Dist.- Purulia, along with 08/10 others for committing house dacoity at Kotshila bazar area under proper section of law.
