In producing herewith the 03 (Three) arrested accused persons namely 1) Arman Khan (21 Yrs) S/O-Amed Ali Khan of Simlapal Paschim Muslimpara, PS-Simlapal, Dist-Bankura, 2) Riyazul Molla (20 Yrs) S/O-Ali Hussain Molla of Do, 3) Riyazul Khan (27 Yrs) S/O-Sagir Khan of Do and two heavy vehicles bearing Registration No. 1) WB67B/4903 (TATA-1109) and 2) WB67C/1937 (Eicher) loaded with potato weighing approx 11.330 mt and approx 14.780 mt respectively.

The brief fact of the case is that today on 08.08.2024 I, SI Sanjib Kr Sen of Manbazar Ps along with C/888 Subhasish Hansda, C/855 Tarun Mahato and C/786 Suchand Mandi were performing special Naka duty near Rajbari more, Patharmohara vide Manbazar PS C.C No.2328/24 Dated.08.08.2024 and vide Manbazar PS G.D.E No. 307 Dated.08.08.2024. At around 21.05 hrs, we intercepted 02 (Two) vehicles having Registration No. 1) WB67B/4903 and 2) WB67C/1937 loaded with potato. On being asked to produce documents regarding the possession of potato, the on boarded driver and khalasi produced two challans in respect of Badal Pa', PS-Balarampur, issued by Joy Guru Alu Bhandar, prop-Shyam Sundar Chira and son, Amlagora, Dist-Paschim Medinipur. On further examination, they stated contradictory statements that led suspicion in my mind. Accordingly, I informed the matter to O/C Manbazar PS to verify the matter with O/C Balarampur PS and after a while, O/C Manbazar PS informed me that the challans are not genuine which is diarized vide Manbazar PS GDE No. 312 and the vehicle loaded with potato are not meant for Balarampur. On further examination, it is disclosed that one Shyam Sundar Chira and son, Amlagora, Paschim Medinipur had given the consignment to the drivers to transport the potato towards Jhakhand side. Their contradictory statements left reasonable doubts that potatoes were procured by means of theft or by any fraudulent activities in order to obtain wrongful profit.

Finding no other alternatives, I conducted the procedure search and seizure as per law. During the process, I arranged for weighing the vehicles at Surja Dharmakata, Kishan Mandi of Manbazar and on being weighed it is found that the vehicle bearing Registration No. WB67B/4903 having approx 11.330 mt of potato and vehicle bearing Registration No. WB67C/1937 having approx 14.780 mt of potato. Accordingly, I seized both the vehicles along with the potatoes, the kata challans and that two challans which were produced by the driver and khalasi of above noted vehicles under proper seizure list with proper audio
