This is to inform you by undersigned that during inspection of LT network unauthorised use of electricity was found. Therefore, I, the undersigned do hereby lodge a complaint empowered by enabling the Electricity act 200351.- Purula subsequently Electricity (Amendment) Act-2007 to the effect that Ranjan Bauri, S.O-Shyamapada Bauri, Vill-Banmahara, PO- Pedda, Dist - Purulia, has committed unauthorised use of Electricity U/s 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 13.08.2024, at about 5:10am, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with Sri Somenath Laha, H.G.S.R.L.M, Manbazar CCC, WBSEDCL & Sri Sourav Mukherjee, Sr, T.S.H, Manbazar CCC, WBSEDCL entered the premise of Ranjan Bauri, S/O-Shyamapada Bauri, Vill-Banmahara, PO- Pedda, Dist -Purulia and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from LTOH line of WBSEDCL.

During inspection, it was found that inspite of having outstanding amount of Rs.74691/- of a disconnected service line of Kalyani Bauri ( Consumer id-202347105) in the same premises, he was using electricity dishonestly U/s 135(1)(a) was detected.

2)One no LED bulb of 09 watt.

One no toto charger along with one no LED of wattage 09 (nine)watt along with 20 mtr two core PVC cable with hooking device is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 5:30 am on dated 13.08.2024. The accused person has committed an offence U/s 135(1)(a) of the Electricity (Amendment) Act-2007.
