Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Dinabandhu Soren, S/O-Haladhar Soren, of Village- Sukapata, P.O-Pirargoria, P.S.- Manbazar, Dist - Purulia, has committed theft of electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 13.08.2024, at about 05.40 am ,I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with, Sri Somenath Laha H.G.Sr L.M,Manbazar CCC & Sri Sourav Mukherjee, Senior TSH , Manbazar CCC entered the premise of Dinabandhu Soren, S/O-Haladhar Soren, of Village- Sukapata, P.O-Pirargoria, P.S.- Manbazar, Dist - Purulia and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from LTOH line of WBSEDCL.

During inspection, it was found that he was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he was using the following electrical equipments-

- 1)Three nos incandescent bulb 100 watts each
- 2)Three nos ceiling fan of 60 watts each

Out of which we seized the following-

- 1) Two core pvc wire of length about 10 (Ten) meter is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 06.00 A.M on dated 13.08.2024. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
