Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Papan Hansda, S/O-Lt.Baidyanath Hansda, of Village- Sukapata, P.O-Pirargoria, P.S.- Manbazar, Dist - Purulia, has committed theft of electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 13.08.2024, at about 06.05 am ,I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with, Sri Somenath Laha H.G.Sr L.M,Manbazar CCC & Sri Sourav Mukherjee, Senior TSH , Manbazar CCC entered the premise of Papan Hansda, S/O- Lt.Baidyanath Hansda, of Village- Sukapata, P.O-Pirargoria, P.S.- Manbazar, Dist - Purulia and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from LTOH line of WBSEDCL.

During inspection, it was found that he was using electricity dishonestly U/S 135(1)(a) was detected.It was also found that he was using the following electrical equipments-

- 1)One no LED tubelight of 20 Watts.
- 2) One no CFL bulb of 09 Watts.
- 3) One no Fan of 60 Watts.

Out of which we seized the following-

- 1) One no of LED tubelight of 20 watts with hooking devices.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 06.25 A.M on dated 13.08.2024. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
