This is to inform you by undersigned that during inspection of LT network a unauthorised use of electricity was found. Therefore, I, the undersigned do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Madhab Bauri, S/o- Arun Bauri, of Village- Bhurasol, P.O- Pedda, P.S.- Manbazar, Dist - Purulia, has committed unauthorised use of Electricity U/s 138(1)(b) of the Electricity (Amendment) Act-2007.

On dated 13.08.2024, at about 6:40am, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with Sri Somenath Laha, H.G.S.R.L.M, Manbazar CCC, WBSEDCL & Sri Sourav Mukherjee, Sr, T.S.H, Manbazar CCC, WBSEDCL entered the premise of Madhab Bauri, S/o- Arun Bauri, P.O- Pedda, P.S.- Manbazar, Dist-Purulia and inspected his premise and found that he was using electricity by reconnecting his disconnected service line (Consumer id-242271602) unauthorisedly.

During inspection, it was found that inspite of having outstanding amount of Rs.11081/- he was using electricity dishonestly U/s 138(1)(b) was detected.

During inspection it was found that he was using the following electrical equipments-

- 1) One no Cooler of 225 watt.
- 2) Three nos fan of 60 watt each
- 3) Three nos CFL of 09 watt.

A CFL of 9 watt was seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 7:00 am on dated 13.08.2024. The accused person has committed an offence U/s 138(1)(b) of the Electricity (Amendment) Act-2007.

The service connection has been disconnected on 13.08.2024. You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
