Dear Sir,

This is to inform you by undersigned that during inspection of LT network unauthorised use of electricity was found. Therefore, the undersigned do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Abhijit Singha Mahapatra, S/O-Subash Singha Mahapatra, of Village- Rajagram, P.O-Jharbagda, P.S.- Manbazar, Dist - Purulia, has committed unauthorised use of electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 27.08.2024, at about 05.42 am, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with, Sri Somenath Laha H.G.Sr L.M, Manbazar CCC, Sri Sourav Mukherjee, Senior TSH, Manbazar CCC, Sri Gopinath Mahato, Senior TSH, Manbazar CCC & Sri Binod Garain H.G TSH, Manbazar CCC entered the premise of Abhijit Singha Mahapatra, S/O-Subash Singha Mahapatra, of Village- Rajagram, P.O-Jharbagda, P.S.- Manbazar, Dist - Purulia and inspected his premise and found that he was using electricity unauthorisedly by direct hooking from nearest LTOH line of WBSEDCL.

During inspection, it was found that as on date 27.08.2024 inspite of having outstanding amount of Rs- 101,549/- (One Lakh one thousand five hundred forty nine rupees, without LPSC) of a disconnected service line of Abhijit Singha Mahapatra (Consumer id-201094496) in the same premises, he was using electricity dishonestly U/S 135(1)(a) was detected.

During inspection, it was also found that he was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he was using the following electrical equipments-

- 1) a water pump of 2hp
- 2) 9 nos of 200 watts incandescent bulb

12 meters black coloured 2 core pvc cable along with hooking devices is seized.


The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 06.04 A.M on dated 27.08.2024. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
