Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Paresh Sarkar, S/O-Gurupada Sarkar**, a permanent resident of **Vill:Hijuly, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **14.08.2024** at about **04:05PM** I, Dhritiman Sardar S/O Rupal Sardar aged about 26 years, AE & SM Saltore CCC, along with Sri Bikash Hazra AE Civil and Sri Joydeb Kundu Sr. OE both attached to Purulia Region Office and Sri Souvik Mudi, J.E. (Gr-II) attached to Saltore CCC and others had been to the village at Hijuly for routine inspection purpose. During inspection it was found that Sri Paresh Sarkar was consuming electricity dishonestly and unauthorisedly in his domestic premises by tapping at the incoming service cable of WBSEDCL thus bypassing the energy meter without registering the actual consumption which resulted loss of revenue of WBSEDCL in respect of **Consumer ID-242062356** to the tune of load **03.05KVA**.

As theft of electricity was detected during inspection the service connection was disconnected from the nearby electrical source and one no of 2core 10sqmm black coloured aluminium pvc cable and two numbers of black coloured stranded copper wire core of assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list but the accused person denied by putting his signature in the Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives obtained but the accused person refrain to sign the same. The service connection vide Con id-**242062356** was disconnected from pole side and outgoing cable from the meter removed a sealed vide no: SSH0994635. The modus of operandi was video graphed. After completion of inspection, the inspection team left the aforesaid premises at about **04:25 PM**.

Thus the accused **Sri Paresh Sarkar, S/O- Gurupada Sarkar, Vill:Hijuly, P.S -Neturia, Dist- Purulia** have committed an offence u/s **135(1)(b)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
