Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Somnath Hari; S/O- Aswini Hari**, a permanent resident of **Vill- Amdhawra, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135(1)(a) of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **30.08.2024** at about **01:20 PM** I, Sri Dhritiman Sardar S/O- Sri Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) attached to Saltore CCC and and Goutam Kumar Pandey, HGTSH both attached to Saltore CCC and others had been to the village Amdhawara for routine inspection purpose. During inspection it was detected that **Sri Somnath Hari** was consuming electricity dishonestly and unauthorisedly in his Commercial premises (Bipodtarini Decorators) by the way of direct hooking for from the nearby LT mains of WBSEDCL which resulted causing loss of revenue of WBSEDCL to the tune of load **0.295 KVA**.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and one no of two core four sqmm black coloured alluminium PVC Cable with socket board and hooking device as a sample assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list with the accused person signed by putting his signature in the Seizure List, Inspection Report and Notice. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives obtained. The inspection team left the aforesaid premises at about **01:40 PM**.

Thus the accused **Sri Somnath Hari; S/O- Aswini Hari,, Vill- Amdhawra, P.S - Neturia, Dist- Purulia** have committed an offence u/s 135(1)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
