Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Sanu Rajak (26 yrs) S/O- Manik Rajak of Vill-Ranipur Colliery, PS-Neturia, Dist-Purulia with seizure of 10 pcs sealed bottles of Dil Khush Country spirit containing 600 ml each (MRP @ Rs. 60/-) & 12 pcs sealed bottles of Dil Khush Country spirit containing 300 ml each (MRP @ Rs. 30/-) which were seized under proper seizure list.

I beg to submit that today (30.08.2024) while I, ASI Shyamal Chandra Mandal, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-1318 Dt. 30.08.2024 & CC No-2345/24 Dt. 30.08.24 and acting on source information after consulting you at about 20:15 hrs reached at Ranipur Colliery village More and held raid in the stationary shop of Sanu Rajak (26 yrs) S/O- Manik Rajak of Vill-Ranipur Colliery, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 10 pcs sealed bottles of Dil Khush Country spirit containing 600 ml each (MRP @ Rs. 60/-) & 12 pcs sealed bottles of Dil Khush Country spirit containing 300 ml each (MRP @ Rs. 30/-) which were seized under proper seizure list duly signed by witnesses under proper videography and out of those labeled 01 (One) bottle each as sample at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 47 BNSS, 2023 and handed over a copy of the same to arrestee.

The arrested accused namely Sanu Rajak (26 yrs) S/O- Manik Rajak of Vill-Ranipur Colliery, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/726 Dipankar Mahato and (2) NVE/487 Kirtan Singh Sardar both are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Sanu Rajak (26 yrs) S/O- Manik Rajak of Vill-Ranipur Colliery, PS-Neturia, Dist-Purulia under proper section of law.
