Subject: Formal Complaint against Mr. S.N. Singh S/O Late Ganesh Singh. Representing himself as Franchise Head, Code 116210018, of Sarbari More Centre (Centre Code - 6674) of Sahara Golden, Sahara Credit Cooperative Society Limited Scheme Residing at beside Birla factory Kulti, Thana - Kulti, Pashim Burdwan, WB -723121 for Fraudulent Misrepresentation and Embezzlement.

Respected Sir/Madam,

I, Arup Majee, son of S/o Late Krista Pada Majee, residing at Vill+Po-Bhamuria, Thana - Neturia, Dist- Purulia, West Bengal -723121 hereby bring to your urgent attention a matter of grave concern involving a fraudulent scheme orchestrated by Mr. S.N. Singh S/O Late Ganesh Singh, who falsely represented himself as an authorized agent of SAHARA GOLDEN.

On the 23rd of December, 2011, I was approached by Mr. S.N. Singh, who claimed to be an accredited agent of SAHARA GOLDEN. He persuaded me to subscribe to a policy bearing membership number 6674110101033, which was purportedly valid from 23rd December 2011 & 28th December 2011 to 23rd December 2026 & 28th December 2026. According to Mr. Singh, the policy required an installment of Rs. 16,000 INR one time for each certificates and after 15 years maturity the amount in return which I will get as promised was Rs. 1, 04,640INR for all the certificates. For, which I opted to pay in that scheme with an investment of Rs. 16,000 INR per certificate and for that I purchased 100 certificates (70 certificates dated on 23rd December 2011 with an cost of Rs 11,20,000 INR and rest 30 certificates on 28th December 2011 with an cost of Rs.4,80,000) which in total worth Rs. 16, 00,000 INR (Sixteen Lakhs rupees) paid by me at my own residence located at Vill+Po-Bhamuria, Thana - Neturia, Dist- Purulia, West Bengal -723121. Also, as said after 15 years of maturity of all the certificate I would get in return Rs. 1, 04, 64,000 INR Throughout this period, I received no indication of any discrepancies or irregularities concerning the policy resulting as said person made breach of trust and cheated me.

Trusting his representations I received no indication of any discrepancies or irregularities concerning the policy. However, upon conducting a recent verification with SAHARA GOLDEN, I was appalled to discover that no such policy exists in my name which are fabricated. This revelation has led me to the inescapable conclusion and I have been egregiously defrauded by Mr. S.N. Singh, who has engaged in a calculated act of deception and embezzlement.

Subsequent to this discovery, I have made numerous attempts to contact Mr. S.N. Singh to seek clarification and restitution. Regrettably, he has consistently ignored my calls and messages, further substantiating his intent to defraud.

I hereby request your esteemed office to register this complaint and initiate a thorough investigation into this matter. I implore you to take stringent legal action against Mr. S.N. Singh for his fraudulent activities, which have caused me significant financial loss and emotional distress. I am prepared to provide all necessary documentation and evidence, including the details of the payments made to Mr. Singh, to facilitate the investigation which has been annexure with this complaint.

This incident has not only caused me considerable financial harm but also shaken my trust in individuals claiming to represent reputed organizations. I earnestly seek justice and the recovery of my hard-earned money. He has committed the crimes under section 406/420/407/467/468.

I appreciate your prompt attention to this serious matter and I am hopeful for a swift resolution.
