Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Mahabir Bauri, S/O-Tarani Bauri**, a permanent resident of **Vill- Jamgoria, P.S - Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 1(a) of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **12.08.2024** at about **02:17 PM** I, Sri Dhritiman Sardar S/O- Sri Rupal Sardar, aged about 26 years, AE & SM Saltore CCC, along with Sri Partha Chakraborty, DE (S&LP) Purulia Region, Sri Souvik Mudi, J.E. (Gr-II) attached to Saltore CCC and others had been to the village Jamgoria for routine inspection purpose. During inspection it was detected that **Sri Mahabir Bauri** was consuming electricity dishonestly and unauthorisedly in his Domestic premises by the way of direct hooking for from the nearby LT mains of WBSSEDCL which resulted, causing loss of revenue of WBSSEDCL to the tune of load **0.255KW**.

As theft of electricity was detected during inspection the illegal hooking line is disconnected & removed from the nearby electrical source and Single core Single wire PVC copper wire of white colour approx 7 mtr route length along with hooking devices has been seized under memo of seizure list in the presence of witnesses and signed by the representative of the accused person on the Inspection Report and seizure list. The above seized materials duly packed and labeled at the inspection site. The inspection team left the aforesaid premises at about **02:40PM**.


Thus the accused **Sri Mahabir Bauri, S/O-Tarani Bauri, Vill- Jamgoria, P.S - Neturia, Dist- Purulia** have committed an offence **u/s135(1)(a)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
