Sub: Lodging of F.I.R of theft of Electricity against GOBARDHAN BAURI, S/o LT. SUDHIR BAURI at his Domestic premises at Bhagabandh, P.S.-Para and thereby committed an offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Sutanu Goswami, S/O – Suresh Chandra Goswami, A.E. & Station Manager of Anara CCC, WBSEDCL received an information to the effect that Gobardhan Bauri, S/o Sudhir Bauri residing at Bhagabandh was committing theft of Electricity at his Domestic premises by bypassing electricity by means of tapping from incoming side of the service cable..

Acting on this information this day 21.08.2024, I along with Sri sayandeep Paul (JE - II), Spandan Maji (Sr. OE), Prabir Nandi (Spot billing supervisor), Goutam Bauri (contractual technical staff) & Bapi Bauri (contractual technical staff) of Anara CCC had been to the house of Gobardhan Bauri . He was present at his house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises.

The premises is a one storied building. The meter is installed at the end of the entrance of that premises. A notice was prepared duly signed by the present user served upon the consumer and held inspection. During inspection, it was detected that, Gobardhan Bauri had bypassed the electricity by means of tapping from incoming side of the service cable bearing meter No: G112229 in the name of Sri Sudhir Bauri at the said premises. Inspection also revealed that Gobardhan Bauri was the actual user of the above mentioned service connection.

Immediately, on my direction the contractual worker (Goutam Bauri & Bapi Bauri) disconnected the above mentioned service connection and removed the Energy meter bearing SI no: G112229

From the evidence so far collected from the inspection of the energy meter, it is well established that Gobardhan Bauri was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

On inspection it is found that he was using the following apparatus :- 1) Led Light 5 Nos.(5*10)=50w, 2) Fan 3 Nos. (3*110)=330w; 3) TV 1 no. =200w, Total (50+330+200)= 580 Watt.

I, Sri Sutanu Goswami, AE & SM of Anara CCC prepared inspection report in his presence i.e. present user (Gobardhan Bauri) and witnesses at the spot and load assessed as 0.580 KW.

I, Sri Sutanu Goswami, AE & SM of Anara CCC prepared Seizure list in respect of the said premises and meter in presence of the present user and witnesses at the spot.

The inspection was held between 01.15 PM to 01.30 PM today after observing all legal formalities. It is well evident that accused Gobardhan Bauri, S/o Lt. Sudhir Bauri of Bhagabandh has committed offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR.
