Sir,

I, Sunil Kumar Sanwaria, S/o- Shankar Lal Sanwaria, R/o- Bunglow No.- 7, Chanchani Colony, Dhaiya, Dist.-Dhanbad, Jharkhand is one of the directors of M/s Krishna Coke Pvt. Ltd., a company incorporated in the year 2000 under the provisions of the Companies Act. The registered office of the said Company is situated at Premises No.- 78, Hazra Road, Kolkata-700029. I am share holder of 2900 shares in the Company. The other prominent share holders of the company are Sunil Kumar Sanwaria and Sons (HUF) of 369300 shares. Till 9th August, 2023 I was one of the directors of the Company. The other Director was Deepak Kumar Sanwaria who is resorting to illegal methods inducted one Manik Kumar Tiwary as a Director of the said Company and by deceitful methods usurped the property of the said Company. The said Company owned a land measuring 6 acres 8 decimals within district of Purulia, P.S.- Para, Mouza - Mahuda, J.L.No.-84 khatiyan no.- 233, various plot nos.

523, 526, 527, 528, 534, 535, 537, 541, 546, 562, 566, 571, 625, 627, 640, 642 and 575. Deepak Kumar Sanwaria knowing it fully well that the said land was not his exclusive property, executed a registered sale deed bearing no. 1/1403/00806/2024 dated 12.03.2024 and transferred the said land in favour of another Company namely M/s Jay Salasarji Power and Steel Ltd. with registered office at 17, Ganesh Chandra Avenue, 4th Floor, P.O. Dharafalla, P.S. Bow Bavan, Kolkata, which is a Company owned by the son of Deepak Kumar Sanwaria. This sale was executed in a clandestine manner by hatching a criminal conspiracy by and between Deepak Kumar Sanwaria, his son Priyesh Kumar Sanwaria in which the accused Company M/s Jay Salasaji Power and Steel Ltd. is equally complicit. Since the vendor Deepak Kumar Sanwaria was not the owner of the aforesaid landed property, he had no right to transfer the same. This act of Deepak Kumar Sanwaria and Priyesh Kumar Sanwaria has caused wrongful loss to the company M/s Krishna Coke Pvt. Ltd. me and other share holders and corresponding wrongful gain to the aforesaid perpetrators of the crime. You are, therefore, requested to take appropriate steps to get the culprits punished as per law.
