Sub-F.I.R against Bidu Bauri, D/O-Gopal Bauri, residing at Village-Kanara, P.O-Gopalpur, P.S-Pancha, Pin-723151, Dist-Purulia for unauthorized drawal of electricity by the way of bypassing of energy meter of W.B.S.E.D.C.L at his premises.

Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that against Bidu Bauri, D/O-Gopal Bauri, residing at Village-Kanara, P.O-Gopalpur, P.S-Pancha, Pin-723151, Dist-Purulia has committed theft of electricity under section 135 clause 1(b) of Indian Electricity Act-2003, subsequently amendment act-2007 on 20.08.2024 at about 03:20 P.M.

I Sri Saikat Mallick, S/O-Himadri Mallick, A.E & S.M of Pancha CCC along with 1) Sri Somnath Soren (J.E Gr-I) under Pancha CCC, S/O-Lt. Pannalal Soren 2) Sri Sandip Mahato (Sr.O.E.) under Pancha CCC, S/O-Lt. Brindaban Mahato, 3) Soumajit Rakshit (O.E.) under Pancha CCC, S/O-Sanjit Kumar Rakshit and other technical staff attached to Pancha CCC entered the premises of Bidu Bauri, D/O-Gopal Bauri, residing at Village-Kanara, P.O-Gopalpur, P.S-Pancha, Pin-723151, Dist-Purulia a consumer of Pancha CCC having Consumer ID- 242309536, Meter No- 0334408 and inspected her premises. During the inspection theft of electricity was detected by the way of bypassing of energy meter of WBSIEDCL with serial no- 0334408 under section 135 clause 1(b) of Indian Electricity Act-2003, subsequently amendment act-2007.

The accused person was consuming electricity dishonestly at her domestic premises by the way of bypassing of energy meter of WBSIEDCL without registering the actual consumption by tampering and inserting wire from incoming PVC cable of energy meter causing considerable revenue loss of WBSIEDCL. During inspection total load was found 0.2KW. From the above bypassing system she uses the following electrical equipment

1) Table Fan-01 no (80 Watt) 2) Light-04 nos (30 Watt each)

The following items were seized from the house of the accused person-

1) Damaged energy meter with 1 no cut out

2) 2 core PVC cable (approx. length- 10 meter)

Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 04:10 P.M on 20.08.2024. The accused person has committed an offence U/S 135 clause 1(b) of I.E Act-2003, subsequently amendment act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
