Corrigendum Letter

Sub: Mob attack at Puncha BPHC Emergency

I would like to inform you that on 21.08.2024 a patient named Biswajit Dhibar, Vill+PO-Puncha, Dist-Purulia brought to Puncha BPHC emergency around 01:00 PM. Dr. Biswajit Tudu on duty Medical Officer attended to the patient and after the primary inspection, he declared his death. Immediately after that, many people gathered at Puncha BPHC emergency room and went to Dr. Biswajit Tudu, who forced him to re-examine the patient. So again he attended to the patient and declared him dead. Suddenly all those people started heavy chaos. Some of them were drunken and used too much abusive language to on-duty medical officer, staff nurses, and other hospital staff. Eventually, the mob got out of control and started threatening the on-duty medical officer to beat and kill him.

I would also like to inform you that I, the undersigned went to Purulia, CMOH office for some official work during this incident. Some of these people also attacked my residential quarter. They kicked on the quarter door, threw stones at windows, and used abusive language to my wife.

Therefore I am requesting you look at the matter.
