Sir,

In producing herewith the three arrested accused persons namely (1) Koushhik Ruidas (35 Yrs) S/O-Bangshi Ruidas of Madhupur, PS- Bandwan, Dist- Purulia (2) Chitta Mahato, (24 Yrs) S/O-Sufal Mahato of Chandra PS-Bandwan, Dist- Purulia and one heavy vehicles bearing Registration No JH05CA/8534 (Mini Truck) loaded with potato weighing approx 4750 KG.

The brief fact of the case is that today on 08.08.2024 I, SI Prabir Kr. Banerjee of Puncha Ps along with SI Narayan Majumdar & C/ 2217 Souvik Rana, and HG/1850 Nakul Karmakar of Puncha PS were performing special Naka duty near Dhadki more, vide G.D.E No 467 and C.C No 1806/24. At around 18.05 hrs, we intercepted 01 (one) vehicle having Registration No. JH05CA/8534 loaded with potato. On being asked to produce documents regarding the possession of potato, the on boarded driver and khalasi produced challan in respect of Manas Gorai, PS-Balarampur issued by Harasundar Sinha Mahapatra, prop- Shiva Durga Alu Bhandar of vill- Bikrampur, Dist-Bankura. On further examination, they stated contradictory statements that led suspicion in my mind. Accordingly, I informed the matter to O/C Puncha PS to verify the matter with O/C Balarampur PS and after a while, O/C Puncha PS informed me that the challan are not genuine which is diarized vide Puncha PS GDE No 475 Dtd.-10.08.24 and the vehicle loaded with potato are not meant for. On further examination, it is disclosed that one Harasundar Sinha Mahapatra and Others, Bikrampur, Dist- Bankura had given the consignment to the drivers to transport the potato towards Jharkhand side. Their contradictory statements left reasonable doubts that potatoes were procured by means of theft or by any fraudulent activities in order to obtain wrongful profit.

Finding no other alternatives, I conducted the procedure search and seizure as per law. During the process, I arranged for weighing the vehicles at Ma Durga Computer Weigh Bridge, Dhadki and on being weighed it is found that the vehicle bearing Registration No JH05CA/8534 having approx 4750 KG of potato Accordingly, I seized the vehicles along with the potatoes, and one challan which were produced by the driver and khalasi of above noted vehicles under proper seizure list with proper audio videography duly signed by the witnesses and arrested the above noted accd. persons maintaining all guidelines and formalities of arrest.

Hence, I pray to start a specific case against (1) Koushhik Ruidas (35 Yrs) S/O-Bangshi Ruidas of Madhupur, PS- Bandwan, Dist- Purulia (2) Chitta Mahato, (24 Yrs) S/O-Sufal Mahato of Chandra PS- Bandwan, Dist- Purulia (3) The owner of vehicle bearing Registration No. JH05CA/8534. 4) Harasundar Sinha Mahapatra of viil- Bikrampur, Dist- Bankura.
