I am Mrs. Kuheli Dey, W/O- Dr. Naba Kumar Biswas, BMOH, Puncha BPHC resides at BMOH quarter at Puncha BPHC campus with my one month baby. Today on 21.08.2024 around 01:30 PM in absence of Dr. Naba Kumar Biswas some drunken people came to my quarter and continuously pushed the door heavily and try to break down the door. After I opened the door they enquired about BMOH then I replied that BMOH went to Purulia today for some official work. Then they started kicking on the door and throwing some stones at windows. They continuously used too much abusive languages and give life threat to me. I am very much shocked with this incident and filling very much unsafe with my baby.

Therefore I am requesting you to investigate the matter and take proper action regarding this incident.
