Sub-F.I.R against Sri Makar Sing Sardar, S/O-Dinabandhu Sing Sardar, residing at Village-Ramnagar, P.O-Menidih, P.S-Pancha, Dist.-Purulia, Pin-723151 for unauthorized drawal of electricity by the way of direct hooking from nearest LTOH of W.B.S.E.D.C.L at his premises.

Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that against Makar Sing Sardar, S/O-Dinabandhu Sing Sardar, residing at Village-Ramnagar, P.O-Menidih, P.S-Pancha, Dist-Purulia, Pin-723151 has committed theft of electricity under section 135 clause 1(a) of Indian Electricity Act-2003, subsequently amendment act-2007 on 27.08.2024 entered his premises at about 01:40 P.M.

I Sri Saikat Mallick, S/O-Himadri Mallick, A.E & S.M of Pancha CCC along with 1) Sri Somnath Soren (J.E Gr-I) under Pancha CCC, S/O-Lt. Pannalal Soren 2) Sri Sandip Mahato (Sr.O.E.) under Pancha CCC, S/O-Lt. Brindaban Mahato, 3) Soumajit Rakshit (O.E.), under Pancha CCC, S/O-Sanjit Kumar Rakshit, 4) Sri Sukumar Dutta (Sr. T.S.H.), under Pancha CCC, S/O-Lt. Jitendranath Dutta, 5) Sristidhar Mahato (Sr.T.S.H.) under Pancha CCC, S/O-Lt. Ganesh Mahato and other technical staff attached to Pancha CCC entered the premises of Sri Makar Sing Sardar, S/O- Dinabandhu Sing Sardar, residing at Village-Ramnagar, P.O-Menidih, P.S-Pancha, Dist-Purulia, Pin-723151 and inspected his premises. During the inspection theft of electricity was detected by the way of direct hooking from nearest LTOH of WBSEDCL at his premises under section 135 clause 1(a) of Indian Electricity Act-2003, subsequently amendment act- 2007.

The accused person was consuming electricity dishonestly at his domestic premises by the way of direct hooking from nearest LTOH of WBSEDCL causing considerable revenue loss of WBSEDCL. During inspection total load was found 0.26KW. From the above direct hooking system he uses the following electrical equipment

1) Bulb-01 no (100 Watt), 2) Fan-01 nos (80 Watt), 3) Tube Light-02 nos (40 Watt each)

The following items were seized from the house of the accused person-

- 1) Two core flexible cable 10 (ten) meter approx.
- 2) PVC switch board 01 (One) number.

Seizure list was prepared at the site and the accused person refused to sign. The inspection team left the premises at about 02:00 P.M on 27.08.2024. The accused person has committed an offence U/S 135 clause 1(a) of I.E Act-2003, subsequently amendment act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
