Sir,

In producing herewith the three arrested accused persons namely 1) Asgar Ali Khan S/O-Helumuddin Khan (29 Yrs) 2) Saifuddin Khan, S/O-Amuruddin Khan (22 Yrs) both of Simlapal Bazar, PS-Simlapal, Dist-Bankura and one heavy vehicles bearing Registration No. bearing registration No- WB-67-C-0741 (Tata 1512) loaded with potato weighing approx 17,510 KG.

The brief fact of the case is that today on 08.08.2024 I, SI Prabir Kr. Banerjee of Puncha Ps along with C/ 233 Baliswar Hansda, and NVF/1047 Dhananjoy Mahato of Puncha PS were performing special Naka duty near Dhadki Village, vide G.D.E No 370 and C.C No 1786/24 and vide Manbazar. At around 20.55 hrs, we intercepted 01 (one) vehicle having Registration No. WB-67-C-0741 loaded with potato. On being asked to produce documents regarding the possession of potato, the on boarded driver and khalasi produced challan in respect of Dukhabhanjan Mahato, Golkunda PS-Purulia (M), issued by Radhashyam Samji Bhandar, prop- Shyamapada Gorai and Others, Simlapal, Dist-Bankura. On further examination, they stated contradictory statements that led suspicion in my mind. Accordingly, I informed the matter to O/C Puncha PS to verify the matter with O/C Purulia (M) PS and after a while, O/C Puncha PS informed me that the challans are not genuine which is diarized vide Puncha PS GDE No-375 Dtd.-08.08.24 and the vehicle loaded with potato are not meant for . On further examination, it is disclosed that one Shyamapada Gorai and Others, Simlapal, Bankura had given the consignment to the drivers to transport the potato towards Jhakhand side. Their contradictory statements left reasonable doubts that potatoes were procured by means of theft or by any fraudulent activities in order to obtain wrongful profit.

Finding no other alternatives, I conducted the procedure search and seizure as per law. During the process, I arranged for weighing the vehicles at Ma Durga Computer Weigh Bridge, Dhadki and on being weighed it is found that the vehicle bearing Registration No WB-67-C-0741 having approx 17,510 KG of potato Accordingly, I seized the vehicles along with the potatoes, the kata challan and that one challan which were produced by the driver and khalasi of above noted vehicles under proper seizure list with proper audio videography duly signed by the witnesses and arrested the above noted accd. persons maintaining all guidelines and formalities of arrest.

Hence, I pray to start a specific case against 1) Asgar Ali Khan S/O-Helumuddin Khan (29 Yrs) 2) Saifuddin Khan, S/O-Amuruddin Khan (22 Yrs) both of Simlapal Bazar, PS-Simlapal, Dist-Bankura 3) The owner of vehicle bearing Registration No. WB-67-C-0741. 4) Shyamapada Gorai of Simlapal, Bankura.
