Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Sasanka Mahato (34 Yrs) S/o- Shaktipada Mahato of Vill- Palashkala, PS- Purulia (M), Dist- Purulia and seized articles 19 (Nineteen) numbers of sealed bottles of Country Sprit styled as "DIL KHUSH" containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (13.08.2024) during my special mobile duty at about 12.45 hrs I, SI Abhijit Singh of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in house at Palashkala village under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 2734 Susanta Panda & NVF- 187 Upinath Tudu of Purulia (M) PS vide GDE No- 739 Dtd. 13.08.2024 rushed to the spot i.e. the house situated at Palashkala village under Purulia (M) PS at 13.15 hrs. After arriving at that spot and as per your instruction we conducted a raid in the house. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Sasanka Mahato (34 Yrs) S/o- Shaktipada Mahato of Vill- Palashkala, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his house for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 19 (Nineteen) numbers of sealed bottles of Country Sprit styled as "DIL KHUSH" containing 600 ml each. In which 01 sealed bottle was taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made in between 13.22 & 13.29 hrs.

I also arrested the involved accused person namely Sasanka Mahato (34 Yrs) S/o- Shaktipada Mahato of Vill- Palashkala, PS- Purulia (M), Dist- Purulia at 13.30 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Sasanka Mahato (34 Yrs) S/o- Shaktipada Mahato of Vill- Palashkala, PS- Purulia (M), Dist- Purulia under proper section of Law.
