I Sri Kuldip Mahatha, S/O – Giridhari Mahatha, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that JAGANNATH DUARI C/O Lt MUCHIRAM DUARI of Vill - KARCHAKULI P.S- Purulia (M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 13.08.2024 I, Sri Kuldip Mahatha (AE&SM), along with Sri Suraj Kumbhakar.JE(Gr-I), Sri Thakur Das Mahato (LM) of Telkalpara CCC, WBSEDCL conducted a raid programme at village KARCHAKULI under Purulia (M) P.S. When our team at about 2:50:00 PM, entered to the Domestic premises of JAGANNATH DUARI, we found that he was enjoying electricity dishonestly by means of Meter Bypass by means of Meter bypassing by way of tampering service cable and run domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable with bypass arrangement and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 3:03:00 PM, after completion of inspection & necessary formalities.
