With due respect, I beg to report that, I ASI Bacchu Ghosh is the IO of Purulia Town PS case No - 145/24 dtd. 25.06.24 U/S 379 IPC. and during primary investigation of the case complicity of one Sahid Ansary @ Terua (21 yrs) S/O Manir Ansary of Doctor Danga, Ward No- 15, PS- Purulia (T), Dist- Purulia transpires in this case and today 01.08.24 he was called for interrogation in c/w the case as his complicity transpires in this case and the persons has the following criminal records

- 1) Purulia (T) PS Case No- 116/24 Dated. 10.05.24 U/S 379 IPC
- 2) Purulia (T) PS Case No- 189/2023 dated 04.12.23 U/S- 461/379 IPC
- 3) Purulia Town PS Case No. 118/22 dated 13/07/22 u/s 379 IPC

We started interrogation on 01.08.24 from 17.30 onwards, during interrogation he could not satisfactorily explain the incriminating circumstances appearing against him and started giving evasive reply. At this stage sensing arrest he suddenly turned violent and to my utter surprise brought out one knife from his pocket and launched attack on me causing injury in my person and thereafter started threatening that if he is arrested he would commit suicide. When one civic volunteer Sarat Modak tried to apprehend him he bit on the hand. We could somehow disarm him but before we could do so he had stabbed himself. After that his family member was informed immediately and he was taken to Deben Mahato Sadar Hospital for treatment and got admitted there. Myself along with CV Sarat Modak also undergone treatment at Deben Mahato Sadar Hospital.

The accused Sahaid Anary @ Terua S/O Manir Ansary of Doctor Danga, Ward No- 15, PS- Purulia (T), Dist- Purulia voluntarily opened attacked to the government servant who are on duty to deter us from our lawful duty and caused severe injury to our persons and used criminal force which is a criminal offence. He also threatened to commit suicide to restrain public servant to do lawful duty.

Therefore I request you to kindly take appropriate legal action against Sahaid Anary @ Terua S/O Manir Ansary of Doctor Danga, Ward No- 15, PS- Purulia (T), Dist- Purulia as per law.
