Sir,

In producing herewith one Sourav Mahato S/O- Akshay Mahato of Vill- Hatuara, P.O- Gengara, P.S- Purulia(M), Dist- Purulia along with one seized motorcycle bearing no WB56W0886 and beg to report that , I ASI Raju Mukherjee now posted at Purulia Town PS beg to state that today (11.08.24) I along with force and lady force were performing anti-crime Naka Checking duty near Sashan Kali Mandir, Barakar Road Ward-21, P.S- Purulia(T), Dist- Purulia vide Purulia Town PS GDE No. 670/24 Date. 11.08.2024 and MCC No – 2523 dated 11/08/2024. During checking we found that two young riding on a motorcycle are coming in excessive speed. Out of suspicion we attempted to stop the motorcycle bearing registration No- WB56W0886 by signaling it but the motorcycle tried to flee away by tweaking the bike. We were aware and could able to stop him. Then I asked the rider the reason about such behavior but the rider started bad behavior with us. Therefore, I detained the vehicle and asked to produce documents against the motorcycle. The rider identified himself as Sourav Mahato S/O- Akshay Mahato of Vill- Hatuara, P.O- Gengara, P.S- Purulia(M), Dist- Purulia but stated that he is not having any document against the motorcycle and threatened us by saying that if he is not released he will cause harm of my job. I again politely asked the rider for the reason for not wearing helmet and reasons to escape from police but he constantly badly behaved with us and used slang languages. I then told him that his offence is not acceptable and we will take legal action against the motorcycle owner. Hearing this he got excited and suddenly jumped on me and started assaulting me with fist and blows and nails. Police force present at the spot tried to rescue me from him and LC 486 Shampa Gorai went to stop him but the person also hit her. Due to the physical assault I received injury in my left hand. I informed my IC Purulia Town PS about the matter and found no other alternative way to stop him I arrested the said rider Sourav Mahato after preparing arrest memo and observing all formalities and brought him to PS. I also seized the said motorcycle suspecting the motorcycle as stolen one bearing registration No- WB56W-0886 to PS for necessary legal action.

After that I got treatment at Deben Mahato Sadar Hospital for my treatment and the treatment slip is annexed herewith.

The accused Sourav Mahato S/O- Akshay Mahato of Vill- Hatuara, P.O- Gengara, P.S- Purulia(M), Dist- Purulia voluntarily opened attacked to the government servants who are on duty to deter us from our lawful duty and caused injury to our person and used criminal force which is a criminal offence.

Therefore, I request you to kindly take appropriate legal action against Sourav Mahato S/O- Akshay Mahato of Vill- Hatuara, P.O- Gengara, P.S- Purulia(M), Dist- Purulia as per law.
