Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(a) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 28/08/2024 at 15:10 Hrs. I Sri Subhajit Pratihar, DE & SM Purulia CCC WBSEDCL along with Chinmoy Maity(JE attached to Purulia CCC) and Anurag Pandey (OE Purulia CCC) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises of Sk Selim, Son of Lt. Sk Kadir, resident of J.K.College Road, Rani bandh, Purulia(T) Thana, Dist Purulia.

During the time of insection at the premises 1 nos of electricity meter was found having serial no L4784052 (Consumer id 201892302, Consumer Name- Sk Selim).

It was observed that Sk Selim has made unauthorized use of electricity under section 135 1(a) by tapping the service wire of the license and connecting it directly to the wiring to run domestic appliances and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 4 nos (80 watt each), Light 8 nos (10 watt each), Pump 1 nos 746 watt, washing machine 600 watt and 1 No Toto 750 Watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service connections in the premises from pole with the help of LT Mobile Van Team and removed & seized 2 feet service cable with the hooking arrangement & prepared seizure list duly signed by the accused.

The inspection team left the premises at about 15.25 Hrs on 28.08.2024.

The accused committed theft of electricity U/S 135 1(a) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
