Sub-FIR against Babu Alt, Nazrul Islam, Annu Ali & Shabana Naaz for physical assault on me, threatened to kill me, denoting to follow ad interim injunction by Purulia court, etc

Sir,

This is to inform you that I, Irfan Ali s/e Late Naushad Ali, resident of Old Police Line, Usman Gali, Purulia want to make the following complains against the aforementioned people.

These people assaulted me physically in Chunabhatti Road, Ward no.10 on the night of 01/08/2024 at around 10.30 to 12.30am, due to which I had a facial injury below my left eye, lower abdomen, thigh & proin region. The pain was extreme so I had my medical treatment in Deben Mahato Govt Medical College & Hospital, Purulla, where I was admitted on 02/08/24 and discharged on 03/08/24.

A portion of the incident is captured in the CCTV foctage where Nazrul Islam hits a punch on my face & Babu Ali pushes me. Neccesary lodging of this complaint as per provisions laid under law maybe done. I also fear other attacks on me and my mother.

There is an ongoing civil suit against Babu Ali & Annu Ali for property related matter which is also my workplace. Reference- Title Suit No.123 of 2024 CNR NO.WBPU-02-000363-2024 to which the Court have ordered ad interim injunction.

Babu Ali & Annu Ali are denying to follow the court order and tried to break into my workplace by mental assault, followed by physical assault,

They have threatened to fall me & my mother overnight whenever they get the opportunity to do

Shabana Naaz has threatened me to put fake allegations of sexual assault & rape case against me, if I do not withdraw Ibe civil case against her husband Flahir All.

Babu Ali & Shabana Naaz have put up fake rumours about me at my location of workplace that I consume alcohol along with friends and create nuisance. This has resulted in creating a negative impact on my reputation in the society and put me in trauma by hurting my Religious Sentiments as a Muslim.

his act of Character Assassination may be noted.

past also they have assaulted my mother mentally and physically at my residential premises everal times after the death of my father and now they threatened to kill her. cts of continuous domestic violence against my mother(widow) has been followed by these dividuals.

also complain hereby that Babu Ali has taken possession of my deceased father's car Regd.No VB-56C-4482 White Colour Ambassador, and kept in hiding. When I asked to return the car, he lenied to return it back. Hence police may take action so as to bring back my father's car and also take necessary action of theft/stealing the property.

These above action maybe taken as complaints against the said individuals for such crimes committed against myself and my mother.

Shabana Naaz is the wife of Babu Ali Chunga Shalli Read, tand No.10, Pumba.

## Order No.02 dated 08,07,2024

The case record is placed before me on strength of a put up petition filed on behalf of the plaintiff and learned Advocate for plaintiff has moved the put up petition and submitted that plaintiff filed an injunction application and to move the same, put up may be allowed.

Let the Injunction application and put up petition be registered as IA No. 1/2024 & IA 2/2024 respectively.

Put up is allowed.

Ld. Advocate for plaintiffs has moved the temporary injunction application under Order 39 Rule 1 & 2 read with Section 151 CPC dated 05.07.2024 [IA No. 01/2024] and prayed for an ad interim order of injunction to restrain the principal defendants from interfering with the possession of plaintiffs over the suit property described in the schedule of the plaint and the injunction application.

Ld. Advocate representing plaintiffs has briefly stated the case of the plaintiffs and contended that one Kamar Jha was the absolute owner of the suit land and he, as per her desire and as the vendee agreed upon, sold out the land by executing a registered deed of Sale on 18.05.1998 with the boundaries in favour of three sons of Ahammad Ali.

That out of the three sons. Nausad died in the year 2020, leaving his son and widow, plaintiff nos. 1 & 2 and a daughter Neha Yasmin, proforma defendant no. 3 and defendant nos. 1 & 2, are the sons of Ahammad Alt and all are in joint possession of suit land.

Learned advocate further contended that after purchase, plaintiffs renovated their interest over the suit land and plaintiffs started water business and also constructed two rooms to reside and to look after his business but principal defendants since 20.06.2024 trying to keep the factory under lock and key along with the common passage of the suit property to cause disturbance in the business of plaintiffs and for that plaintiffs asked for partition but principal defendants denied and if the principal defendants are not restrained from their unlawful acts, there would be severe injustice to the plaintiffs.
