Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Pratham Bauri (40 Yrs) S/o- Lt. Mahadev Bauri of Vill- Sindurpur, PS- Purulia (M), Dist- Purulia and seized articles 09 (Nine) numbers of sealed bottles styled as "Kingfisher Strong (BEER)" containing 650 ml each along with seizure list and Memo of Arrest.

I beg to state that today (25.08.2024) during my mobile duty at about 17.55 hrs I, SI Basudeb Acharya of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a Line Hotel under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 229 Asit Malla & C/- 2735 Soumen Nayak of Purulia (M) PS vide GDE No- 1473 Dtd. 25.08.2024 rushed to the spot i.e. the TATA Line Hotel situated at Dumurdih morh under Purulia (M) PS at 18.35 hrs. After arriving at that spot and as per your instruction we conducted a raid in the Line Hotel. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Pratham Bauri (40 Yrs) S/o- Lt. Mahadev Bauri of Vill- Sindurpur, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he is the worker of said Hotel. He also stated that he was selling this liquor illegally in the Line Hotel. On demand the arrestee failed to produce any valid document in respect of selling and possession of said liquors in this Line Hotel. Subsequently, I seized 09 (Nine) numbers of sealed bottles styled as "Kingfisher Strong (BEER)" containing 650 ml each. In which one sealed bottle was taken as a sample. I seized the same under proper seizure list in presence of witnesses, duly signed by the witnesses as well as the arrested accused person. The seizure was made between 18.25 and 18.45 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Accordingly, I arrested the involved accused person namely Pratham Bauri (40 Yrs) S/o- Lt. Mahadev Bauri of Vill- Sindurpur, PS- Purulia (M), Dist- Purulia after maintaining all formalities regarding arrest and NHRC guidelines, issued Memo of Arrest. Informed him regarding the ground of arrest and also informed his family members. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Pratham Bauri (40 Yrs) S/o- Lt. Mahadev Bauri of Vill- Sindurpur, PS- Purulia (M), Dist- Purulia (Seller) under proper section of Law.
