In producing here with one arrested accused person namely Kanchan Kumar (24 years) S/O- Purnachandra Kumar of Vill- Kotshila, PS- Kotshila, Dist- Purulia along with seized 200 (Two Hundred) bags potato (each bag contains approx 41 Kg), one Tata 1512 vehicle having Reg. No-WB/55B/3897 and one Orange colour tarpaulin. (details of seized articles are mentioned in attached seizure list), to the effect that today on 09.08.2024, I SI Subrata Sarkar along with C/2735 Soumen Nayak, C/1392 Pradip Kr Pathak, all are of Purulia(M) PS, Dist- Purulia were engaged in Special mobile duty vide Purulia(M) PS CC No-2462/2024 dt-09.08.2024. In course of Special mobile duty, at about 10:35 hrs, I neceived a tip off that one suspicious truck is transporting some suspicious goods suspected to be theft on Dumdumi-Sihali Village road. Accordingly I shared the information to I/C, Purulia (M) PS and as per his direction I proceeded towards the said place to work out the information. At about 12:35 hrs I along with my accompanied force reached at Dudpania football ground on Dumdumi-Sihali village road under Purulia(M) PS area near fharkhand interstate border point, I found that one vehicle having Reg. No- WB/55B/3897 is coming from Dumdumi side towards Sihali through village kachha Road. I along with my force stopped the vehicle beside Dudpania football ground on Dumdumi-Sihali village road and found that the dala of vehicle is cover with Orange colour tarpaulin. On asking the driver, he disclosed his name as Kanchan Kumar (24 years) S/O- Purnachandra Kumar of Vill- Kotshila, PS- Kotshila, Dist- Purulia and he also disclosed that he is carrying 200 (Two Hundred) bags potato (each bag contains approx 41 Kg) in the data of the vehicle. On demand, he failed to produce any valid papers or documents in respect of the said Potato and the vehicle and any satisfactory answers. There is several reason to believe that the driver was carrying 200 (Two Hundred) bags potato (each contains 41 Kg.) illegally by means of theft as he could not able to produce any valid documents in respect of 200 (Two Hundred) bags potato & owner details of the vehicle having Reg. No- WB/55B/3897. Driver of the vehicle namely Kanchan Kumar, owner of the vehicle having Reg. No-WB/55B/3897 and others are involved in this clandestine business.

Accordingly, I seized the article from the possession of accused person after preparing proper seizure list duly signed by the witnesses. The seizure procedure was done in between 12:55 hrs to 13:10 hrs. Then I arrested accused person namely Kanchan Kumar (24 years) S/O- Purnachandra Kumar of Vill-Kotshila, PS- Kotshila, Dist- Purulia after preparing proper arrest memo after maintaining all the formalities as per NHRC guide line. I also issued Check List, The Audio & Videography of entire processes of search

Under the above circumstances, I therefore pray that a specific case may kindly be started against the arrested accused person namely 1) Kanchan Kumar (24 years) S/O- Purnachandra Kumar of Vill-Kotshila, PS- Kotshila, Dist- Purulia who is the driver of the vehicle bearing Reg. No. WB/55B/3897, 2) owner of the vehicle bearing Reg. No. WB/55B/3897, 3) others and arrange for its investigation.
