Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Kalachand Rajwar (52 Yrs) S/o- Abdul Rajwar of Vill- Malthore School Para, PS- Purulia (M), Dist- Purulia and seized articles 20 (Twenty) numbers of sealed bottles of Country Sprit styled as "DIL KHUSH" containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (22.08.2024) during my mobile duty at about 17.25 hrs I, ASI Sujit Mondal of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a house of Malthore village under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force C/- 248 Arabinda Roy & HG- 1576 Shaktipada Mahato of Purulia (M) PS vide GDE No- 1279 Dtd. 22.08.2024 rushed to the spot i.e. in a house situated at Malthore village under Purulia (M) PS at 18.15 hrs. After arriving at that spot and as per your instruction we conducted a raid in the house. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Kalachand Rajwar (52 Yrs) S/o- Abdul Rajwar of Vill- Malthore School Para, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his house for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 20 (Twenty) of sealed bottles of Country Sprit styled as "DIL KHUSH" containing 600 ml each. In which 01 sealed bottle was taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was done between 18.25 to 18.45 hrs.

I also arrested the involved accused person namely Kalachand Rajwar (52 Yrs) S/o- Abdul Rajwar of Vill- Malthore School Para, PS- Purulia (M), Dist- Purulia after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person. The whole process of raid, seizure, labelling, arrest, has been videography.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Kalachand Rajwar (52 Yrs) S/o- Abdul Rajwar of Vill- Malthore School Para, PS- Purulia (M), Dist- Purulia under proper section of Law.
