Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused has committed interference with meter or work of licensee U/S 138 1/b of the electricity Act 2003, Amendment of 2007 as stated here under.

On 28/08/2024 at 14.25 Hrs. I, Sri Subhajit Pratihar DE & SM Purulia CCC WBSEDCL along with Chinmoy Maity (JE Purulia CCC) and Anurag Pandey (OE Purulia CCC) went to make an inspection to workout upon a source information regarding unauthorized reconnection of a service connection bearing consumer id no 202259699 in the name of Pappu Jaiswal resident of Flat No 4,4<sup>th</sup> Floor, Shibam Apartment, Nilkuthidanga. The service connection was disconnected by WBSEDCL on 29.09.2023 due to non-payment of outstanding bill with Meter reading 16661. The outstanding is Rs 43,789.17 excluding applicable late payment surcharge as per regulation. The service connection is in deemed disconnected status in our database. The team entered the premises of Pappu Jaiswal.

During the time of inspection at the domestic premises 1 nos of electricity meter was found having serial no 084810837 (Consumer id 202259699, Consumer Name Pappu Jaiswal). The meter was connected to the mains through a service cable. The user was enjoying electricity service and the reading on the meter was recorded 18604 KWH.

In presence of the inspection team and the user it was observed that Pappu Jaiswal has made unauthorized reconnection of the service connection bearing consumer id no 202259699 and has made offence under section 138 1/b. Accused has made huge financial loss to WBSEDCL.

After detection of unauthorized reconnection of service line illegally and dishonestly, the inspection team disconnected the service line in the premises from pole with the help of LT Mobile Van Team.

The inspection team left the premises at about 14.56 Hrs on 28.08.2024.

The accused committed interference with meter or work of licensee under section 138 1/b of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
