Today morning BSS engineer & Technician visit the site and found 3 Pcs AZNA module theft, 4 pcs Jumper Cable damaged, One CRPI cable (50 Mtr.) cut and damaged, One SFT damaged, One AZNA power connector damaged.

Therefore, I earnestly request you to take necessary legal action regarding these incidents.
