

Complainant respectfully sheweth:-

1. That the complainant is a household/home-maker and the permanent resident of aforesaid address where she resides alongwith her family members.
2. That on the day of incident all the acced. persons infurthe rance of their common intention tried to occupy some portion of landed property of petitioner's house just adjacent to the dwelling house of the petitioner's family by raising fencing in which complainant raised protest whereupon acced. grew furious and attacked the complt. brutally. Acced. Najrul Ansary and Saddam Ansary assaulted the complt. on her head with lathi as a consequence complt. fell on the ground and cried for help to get rid of the acced. and somehow husband of the complainant rushed to the spot and tried to save the complt. but acced. Hasen Ali and Samad Ansary also kicked and assualted the complt. and her husband and acced. Hasen Ali also abusd the complt. insulting the womenhood of the complt. Be it mentioned husband of the complt. also sustained injury in the hand of the acce. person by and large but complt. sustained grave injury with blood shed. Needless to say complt. under the active help of her husband anyhow escaped therefrom into her Bastu but acced. did not spare the complainant they also trespassed into the Bastu of the complt. with iron rod & lathi etc. and shouted, "BARIYA AAI AJ SES KORE DEBO KE BANCHAI DEK CHI EKDOM MATHA NAMIYE TARPOR JABO" However family members of the complt. saved her from the ~~buted~~ hands of the acced. persons as such they left the house otherwise acced. persons would have committed murder in the house of the complt.

That the complt. reached to Raghunathpur P.S. on the same day informed bleeding injury and reported the matter but P.S. ~~compt.~~ instructed the complt. to get treated with Hospital as such complt. undergone treatment at Raghunathpur S.S Hospital where she remained admitted for two days owing to her injury.

4. That as no action had taken by the Raghunathpur P.S. against the acced. person as such complt. sent her grievances to the S.P. Purulia through Regd. post on 12-07-24 but till date no action taken to that effect. Hence complt. seeking her remedy before Ld. court.

It is therefore prayed that necessary direction be given to the I/C Raghunathpur to cause investigation into the case after treating the instant petition as an F.I.R. in terms of sec. 156(3) CrP.C/ 175 BNSS.
