Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Md Samir, S/O- Late Md Sahid was enjoying electricity unauthorisedly i.e. bypass of energy meter by cutting of incoming service connection cable and due to this reason he had committed theft of electricity u/s 135 (1)(b) of the Electricity (Amendment Act-2007).

On 28.08.2024 at 03:00 pm I, Achintya Mahata, DE & Station Manager Raghunathpur CCC, WBSIEDCL, along with Sri Dayamay Mahata, Sr. TSH, S&LP, Purulia Regional Office, Sri Aditya Kumar Rajak, JE, Gr-I, Raghunathpur CCC, WBSIEDCL, Sukingkar Dutta, JM(HR&A), Raghunathpur CCC, WBSIEDCL, entered the premises of that Md Samir, S/O- Late Md Sahid at Bhakatpara, W.No-02, Raghunathpur, Purulia, having consumer ID-201054733, Meter No-82461439 and inspected his premises. During inspection, theft of electricity was detected i.e. he was using electricity dishonestly by tapping the incoming service cable of the energy meter installed in the said premise and therefore bypassing of the energy meter of WBSIEDCL i.e. u/s 135 (1)(b) was detected.

From the above arrangement, he was using the following electrical equipments:

- 1) Electric Bulb-04 nos
- 2) Electric Fan-03 nos
- 3) T.V-02 Nos
- 4) Fridge- 01 No

Out of which, I seized the following electrical items:

- 1) PVC 2 core cable along with bypassing arrangement— 1 ft (approx)
- 2) Change Over switch- 01 No

Seizure list was prepared at the site, the accused person signed. After that the inspection team left the premises at 03:20 pm on 28.08.2024. The accused person has committed an offence u/s 135 (1)(b) of the Electricity Act-2003 (Amendment Act-2007).

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
