One Dilip Bouri, S/O Nimai Bouri of Vill: Chinpina, PO & PS: Raghunathpur, Dist: Purulia, was called upon a hearing, as on today for a particular Misc Case, got submitted earlier, being based on his prayer. However, he, beyond this authority's knowledge, in any way, at all, suddenly brought a ferocious mob into the hearing. They came on the hearing table of Md. Sadaab Ehsan, Revenue Officer and unnecessarily started arguing against his logic. After a minute or two, the throng, led by that Dilip Bouri, as well as, supported by one Tarak Bouri endlessly started using cumulative abusive expletives, towards the Revenue Officers, present there, namely Satyajit Mukherjee, Debasis Maity and Manas Chakraborty. Later in my presence they attacked on the desk and damaged a light and a desktop, that, indeed are the government properties.
