Complainant most respect fully sheweth:-

1. That the complainant is a resident of vill: Fulberia, PS:- Salanpur, and his matrimonial house/in-law's house is at vill /PO: Rakshatpur, PS: Raghunathpur, Dist: Purulia, which is under the jurisdiction of this Ld. court.
2. That only daughter of the complainant BRISTI MAJEE herein after to be referred as victim in the instant petition used to persue her studies from her maternal uncle's huse at Rakshatpur under the supervision of maternal uncle and grand mother. He it mentinned victim was pursuing her graduation from Raghunathpur college and even she used to take her tuition at Raghunathpur.
3. That on the day of incident victim left her maternal uncle's house alike other days for her tuition at Raghunathpur, but surprisingly after lapse of sufficient time she did not return to Rakshatpur as such under an utter surprise her maternal uncle made ~~rigorous~~ search till evening but in vain. As such maternal uncle of the victim informed the matter to the I/C Raghunathpur vide a missing diary as victim went missing on the way of her tuition .
4. That during eger search on the part of maternal uncle and father of the victim came to know that the acced. person no: (i) named above has kidnapped the victim from Raghunathpur & ^{all the} acced. persons have detained the victim with some malefide purpose.
5. That acced. persons are not at all related with the complt or his family as such complainant apprehends that purpose of such kidnapping must be for the purpose of compelling the victim for marriage. Needless to say after kidnapping victim has

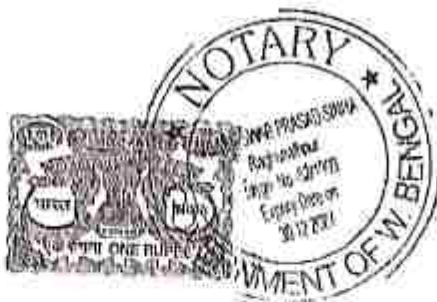
been detained under the custody of the acced. persons. As a result the fact victim had no any affairs with the acced. no. (i) and she used to live with her maternal uncle and grand mother who even never smelt any affair with he acced. person no:-(i)

6. That the complainant reported the matter with Raghunathpur P.S. on 28-06-24 with specific name of the acced. persons stating their involvement in the crime of kidnapping but no action has taken by the P.S. authority, thereafter complainant sent his grievances to the S.P. Purulia on 01-07-2024 through Regd. post but because infructuous, therefore finding no other alternative complainant seeks his remedy before the Ld. court.

Therefore prayed that a necessary action giving direction upon the I/C Raghunathpur for causing investigation into the matter after treating the instant application as an F.I.R. may kindly be passed.
