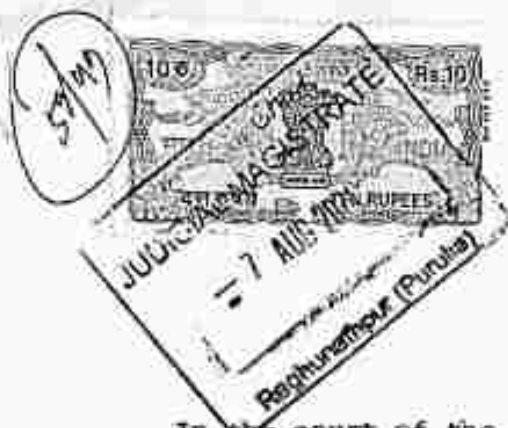

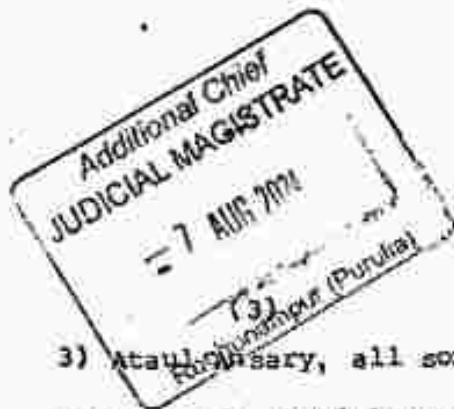

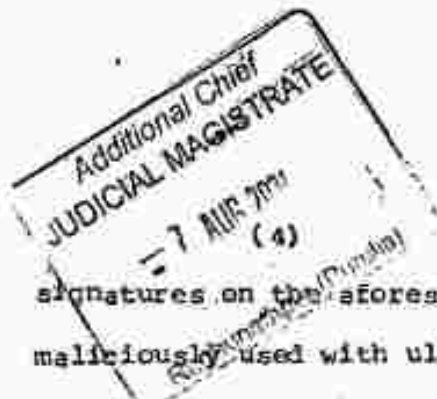
The humble petition of the complainant
Most respectfully sheweth :-

1. That your petitioner/complainant right now doing his masters course in Mathematics at Sidhu Kanhu Birsha University in the District of Purulia. He has got high ambition and as such he is preparing at the same time for CSIR NET Exam. W.B.S. Exam and that he is also taking sincere preparation for the Higher post under state and central Govt.
2. That on 31/01/2023 at about 11.00 P.M. when the complainant was at his friends quarter (Quarter No. F 95B) under S.T.P. ^{SET} Township alone for study, 5 miscreants namely (1) Farukh Ansary (2) Muktar Ansary

3) Ataul Ansary, all sons of Noor Mahammad Ansary (4) Dildar Ansary, s/o Ataul Ansary and (5) Nasiruddin Ansary, s/o Alimuddin Ansary trespassed into the quarter aforesaid all on a sudden and tied the complainant's hands, legs and by putting a piece of cloth into the mouth and took him to the house of the accused Muktar Ansary of Parbahal under Santaldih P.S. with the help of a 4 wheeler and the complainant found over there that other rest 5 accused persons named above and thereafter all the 10 accused persons aforesaid ordered the complainant to marry the elder daughter of accused Muktar Ansary namely, Tamama Khatun to which the complainant refused. to do so whereupon the accused Farukh Ansary, Ataul Ansary, Dildar Ansary being instigated by rest 7 accused persons threatened him on putting knives on his neck and also threatened with dire consequences to burn the complainant on sprinkling petrol and that the complainant inspite of such grave threatening refused to marry whereupon accused Muktar Ansary, Nasiruddin Ansary threatened to commit rape upon his minor female members of the family and thereafter all the accused persons removed the complainant's wearing apparels and assaulted him by fists and blows and also tortured the complainant sexually. The accused persons also procured the signatures of the complainant on some papers printed in Urdu or Arbi script by force illegally. The complainant subsequently came to learn that those

signatures on the aforesaid printed papers had been maliciously used with ulterior motive showing that the marriage between the complainant and the aforesaid minor Tamanna Khatun had been completed according to Muslim rites but the facts remain in this respect that the complainant did not do so at all and the documents have been prepared by accused persons illegally behind the back of the complainant.

3. That the accused persons after procuring the signatures of the complainant released him threatening with a dire consequences. The complainant got so severely frightened that he would not disclose the incident to anybody initially and practically speaking for that heinous act from the part of accused persons the complainant became the victim of mental tortures and he suffered loss to his career considerably. The complainant also came to learn from the school namely, S.T.P.P. Girls High school (H.S.) where the aforesaid Tamanna Khatun studies that the latter's date of birth is 08/07/2007, so it can be easily presumed that on 31/01/2023 her age was 15 years 6 months 23 days and for that learning the complainant became mentally depressed severely and he came to learn also that the accused persons had/have a plan to doom the bright career of the complainant.

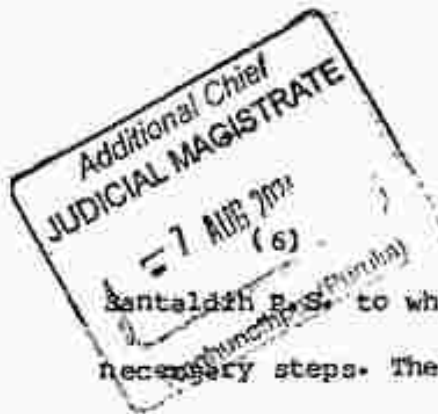

4. That the complainant during his mental suffering the accused persons on 26/06/2024 came to the house of the accused accompanied by minor Tamanna Khatun and all the accused persons told the complainant to accept and allow said minor Tamanna in his house with ill-motive to which the complainant refused to do so whereupon all the accused persons got infuriated and threatening the complainant and his relatives including the female members in a very nasty and fearful way and that ~~when~~ the complainant being frightened went to Santaldih P.S. for the safe guard from the hands of the accused persons to which the latter left the house of the complainant with a threatening to implicate the complainant and his family members in various criminal cases particularly for the purpose of spoiling the complainant's career. It is pertinent to mention that the accused Nasiruddin Ansari and Atau Ansari gave marriage of several minor girls of the locality illegally with the help of Jama Masjid committee, Parbahal and in this respect if the registers maintained by the Masjid committee are looked into the utter illegalities will come to open day light.

5. That the complainant reported the matter detailing everything against the accused persons on 26/06/2024 at

Santaldih P.S. to which the duty officer assured to take necessary steps. The complainant also sent same written complaint to the I/C, Santaldih P.S. by post for proper relief but yielded nothing to which the complainant being frustrated sent an appeal on 01/07/2024 before the S.P., Purulia enclosing the copy of P.I.R. dated 26/06/2024 with a prayer for taking necessary steps against the miscreants but to no result till date and as such this appeal before the Id. court for proper relief and justice.

It is therefore prayed that the I/C, Santaldih P.S. may kindly be directed to investigate the case u/s 175 B.N.S.S. Act treating the complaint as P.I.R.
