Sub : Prayer for lodging FIR against accused Akul Ch. Modak (58 yrs) S/O - Lt. Satish Ch. Modak of Kanki Bazar (Hattola), PS-Santalalidh Dist- Purulia, U/S 46 A (c) Bengal Excise Act, 1909.

Sir,

In producing herewith one arrested accused person named as Akul Ch. Modak (58 yrs) S/O - Lt. Satish Ch. Modak of Kanki Bazar (Hattola), PS-Santalalidh Dist- Purulia along with seizure - list and seized items as described below, I beg to state that today (13.08.2024) at about 19.15 hrs during evening mobile duty I received a source information to the effect that the country spirit (Dilkhush) has been kept at near STPS 1 no. gate, Kanki Bazar under this PS in an unnamed shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santalalidh PS and as per order of I.C Santalalidh P.S. I along with SI Habibur Rahman & force left for near Kanki Bazar to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to an unnamed shop of Akul Ch. Modak near STPS gate no. 1, Kanki Bazar, P.S. Santalalidh at about 19.30 hours. Seeing police party some unknown persons in front of unnamed shop of Akul Ch. Modak were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit (Dilkhush) & foreign liquor for selling and he was the owner of the unnamed shop. However, I along with said accused started a search inside the unnamed shop of Akul Ch. Modak and found the following item in the said house -

1) 08 (eight) bottles country spirit "Dilkhush" each bottles containing 600 ML.

01 (one) bottle of 600 ML taken (Dilkhush) out of the above as sample packet, labeled and sealed with sealing wax.

2) 12 (Twelve) bottles country spirit "Dilkhush" each bottles containing 375 ML. 01 (one) bottle of 375 ML taken (Dilkhush) out of the above as sample packet, labeled and sealed with sealing wax.

3) 10 (Ten) bottles MCDowell's No. Rum each bottle containing 180ML. 01 (one) bottle of 180 ML taken (Mc Dowell's No. 1 Rum) out of the above as sample packet, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing such country spirit & foreign liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 19.40 hrs and 19.50 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit & foreign liquor illegally without any valid papers in his unnamed shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 20.15 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Akul Ch. Modak (58 yrs) S/O - Lt. Satish Ch. Modak of Kanki Bazar (Hattola), PS-Santalalidh.
